#### **ONE HEALTH & SUSTAINABILITY**

People and animals share the same environment, and people depend on animals for livelihood and companionship. We are the only profession routinely working at the interface of animal, human and environmental health. Sustainable veterinary medicine aims to provide for the needs of people and animals with a minimal impact on the environment.

Veterinarians call upon EU policy makers to engage in One Health and support us in our vital role of protecting animal health and welfare, public health and the environment.

## PUBLIC HEALTH & FOOD SAFETY

The health and welfare of people and animals is closely linked: 60% of existing infectious diseases in humans have an animal origin. Animals can also be a source of pathogens in food. We play a crucial role in the detection, prevention and control of diseases of animal origin, thereby protecting public health.

Veterinarians call upon EU policy makers to provide us with adequate legislation, enforcement and infrastructure to help us protect public health and food safety.

## ANTIMICROBIAL RESISTANCE

Antimicrobials are medicines used to treat infections. They are essential for the protection of human and animal health and welfare, and have saved the lives of millions of people and animals. However, excessive or inappropriate use can lead to the emergence of resistant microorganisms, rendering antimicrobials ineffective.

Veterinarians call upon EU policy makers to empower us in preserving the efficacy of antimicrobials through improved disease prevention and advocating the responsible use of medicines.
